- To search for and prepare the record for disclosure, R15,00 for each hour or part (f) of an hour, excluding the first hour, reasonably required for such search and preparation.
- (2)For purposes of section 22(2) of the Act, the following applies:
  - Six hours as the hours to be exceeded before a deposit is payable; and (a)
  - one third of the access fee is payable as a deposit by the requester. (b)
- (3)The actual postage is payable when a copy of a record must be posted to a requester.
