

SITUATIONAL REPORT No. 29

Recent Updates

- To date, there are NO confirmed COVID-19 cases within South Africa
- National Department of Health's Port Health in collaboration with the National Institute for Communicable Diseases (NICD), hosted a training for port health officials from across the country on COVID-19, 2 March
- The South African government has assured the public that it is ready to tackle the threat of the coronavirus. The quarantine facility for the 151 returning South Africans from Wuhan is a highly secretive military location. In addition, the two South African's that have tested positive for SARS-CoV2 on the Diamond Princess cruise ship will only return once they test negative and complete their period of quarantine in Japan.
- Global confirmed case numbers are reported as 89198, with 45175 recovered and 3048, 1 March https://gisanddata.maps.arcgis.com/apps/opsdashboard/index.html#/bda7594740fd40299423467b48e9ecf6
- Five new countries, Azerbaijan, Ecuador, Ireland, Monaco and Qatar, reported cases of COVID19. This takes the total numbers of countries with confirmed COVID-19 to 58.
- Algerian health authorities have confirmed two new cases of COVID-19, a woman and her daughter aged
 53 and 24 years respectively, 2 March
- Egyptian health authorities reported that one foreign national had tested positive for SARS-CoV 2, bringing the total number of confirmed cases of COVID-19 in the country to two, 1 March
- The number of confirmed cases in Hubei province, China, has increased for two successive days after a period of decline. WHO is monitoring the situation and working to understand its possible significance.
