Preferences are offered to tenderers for Broad-Based Black Economic Empowerment (B-BBEE) Status Level of Contribution in terms of the Preferential Procurement Regulations, 2022. Exempted Micro Enterprises (EME) or Qualifying Small Enterprises (QSE) the specific goals will be applicable.

Only tenderers who are already registered in terms of the Construction Industry Development Regulations in cidb grading designation **2ME** or higher are eligible to submit proposal.

COMPULSORY BRIEFING AND SITE INSPECTION

A <u>compulsory</u> clarification meeting will take place at the **NHLS_Johannesburg Forensic Chemistry Laboratory**, currently known as **FCL**, situated at 110 Joubert Street Cnr Kotze, Braamfontein on the 13 February 2024 at 9h:15am.
