Technical Evaluation Criteria for bidders and Speculation of Vitamin C / Ascorbic Acid.

Supply and delivery of a pharmaceutical grade Ascorbic Acid (Vitamin C) to SAVP Small Animal Unit for a period of 36 months.

1. Ascorbic Acid (Vitamin C).

Ascorbic Acid (Vitamin C) is a white to very pale-yellow crystalline powder with a pleasant sharp acidic taste. Almost odourless. Molecular formula of Ascorbic Acid / Vitamin C is C₆H₈O₆. Ascorbic Acid or Vitamin C is an essential nutrient also required by laboratory animals such as Guinea Pigs and it is necessary to maintain connective tissues and bones including functions as a reducing agent and coenzyme in several metabolic pathways.

Ascorbic Acid (Vitamin C) is required monthly: -

- Supply and deliver 25kg of Ascorbic Acid every six (6) months to SAVP Small Animal Unit department.
- The Ascorbic Acid / Vitamin C must be pharmaceutical grade compliant to monograph Ph. Eur.0253.
- Supply a Certificate of analysis with every delivery.
