Delays in the supplier's performance

- i. Delivery of the goods and performance of services shall be made by the supplier in accordance with the time schedule prescribed by the purchaser in the contract.
- ii. If at any time during performance of the contract, the supplier or its subcontractor(s) should encounter conditions impeding timely delivery of the goods and performance of services, the supplier shall promptly notify the purchaser in writing of the fact of the delay, its likely duration, and its cause(s). As soon as practicable after receipt of the supplier's notice, the purchaser shall evaluate the situation and may at his discretion extend the supplier's time for performance, with or without the imposition of penalties, in which case the extension shall be ratified by the parties by amendment of contract.
- iii. The right is reserved to procure outside of the contract small quantities or to have minor essential services executed if an emergency arises, the supplier's point of supply is not situated at or near the place where the supplies are required, or the supplier's services are not readily available.
- iv. Except as provided under GCC Clause 25, a delay by the supplier in the performance of its delivery obligations shall render the supplier liable to the imposition of penalties, pursuant to GCC Clause 22, unless an extension of time is agreed upon pursuant to GCC Clause 22.2 without the application of penalties.
- v. 1. PURPOSE

The National Health Laboratory Service (NHLS) invites suitably qualified and experienced service providers to submit proposals quotation for DMP stationery

2. BACKGROUND

The NHLS is a statutory organisation established under the National Health Laboratory Service Act 2000.

The objects as defined in the NHLS Act are as follows:

- a) Provide cost-effective and efficient health laboratory services to-
 - i. All public sector health care providers;
 - ii. Any other government institution inside and outside of the Republic that may require such services; and
 - iii. Any private health care provider that requests such services:
- b) Support health research; and
- c) Provide training for health science education

During the 2023/24 external audit, there were numerous audit findings that indicated that the NHLS is not compliant with the accounting standard, GRAP 23. This specifically relates to facilities that the NHLS occupy within the relevant health care facility which are generally owned by the respective provincial Department of Health. GRAP 23 indicates that the NHLS needs to calculate the rental rates for each of these facilities and disclose it as Revenue in Kind in the entity's annual financial statements.

The extract from the 2023/24 Audit report is as follows:

Revenue from non-exchange transactions was not recognised in accordance with GRAP 23, Revenue from Non-exchange Transactions (Taxes and Transfers). The public entity did not recognise services received in kind by the public entity from various Departments of Health relating to the laboratory accommodation as revenue.

The NHLS therefore, wishes to appoint a reputable service provider to supply and deliver once off stationery to DMP.
