- c) All Copyright and Intellectual Property herein vests with NHLS and its Client.
- d) Late and incomplete submissions will not be accepted.
- e) SBD 7 (Form of offer) must be completed, and should the total RFQ prices differ, the one indicated on the price declaration shall be considered the correct price.

Delays in the supplier's performance

If at any time during performance of the contract, the supplier or its subcontractor(s) should encounter conditions impeding timely delivery of the goods and performance of services, the supplier shall promptly notify the purchaser in writing of the fact of the delay, its likely duration, and its cause(s). As soon as practicable after receipt of the supplier's notice, the purchaser shall evaluate the situation and may at his discretion extend the supplier's time for performance, with or without the imposition of penalties, in which case the extension shall be ratified by the parties by amendment of contract.
- iii. The right is reserved to procure outside of the contract small quantities or to have minor essential services executed if an emergency arises, the supplier's point of supply is not situated at or near the place where the supplies are required, or the supplier's services are not readily available.
- iv. Except as provided under GCC Clause 25, a delay by the supplier in the performance of its delivery obligations shall render the supplier liable to the imposition of penalties, pursuant to GCC Clause 22, unless an extension of time is agreed upon pursuant to GCC Clause 22.2 without the application of penalties.

Soundcore Space Q45 by Anker

As Anker's new flagship wireless over-ears, the Soundcore Space Q45 feature three-stage noise cancelling to filter low, mid and high frequencies, an adjustable transparency mode and support Bluetooth 5.3 and LDAC technology, a premium audio codec. Individual earpiece and sound settings can also be made via the Soundcore app.

Wearing comfort of the Soundcore Space Q45

The Soundcore Space Q45 weigh 295 grams and have pivoting and retractable cups. This allows the over-ears to be transported in a space-saving manner in the hard-shell case supplied, and they adapt flexibly when worn. The headband size adjustment also covers a wide range, from small to large heads. The fit is neither too loose nor too tight, meaning the headphones do not slip during a short jog and do not create an unpleasant feeling of pressure. According to the manufacturer, the hinges are made of a robust aluminium alloy, while the ear pads are made of skin-friendly materials. I noticed that this closed over-ear model already has high passive insulation properties, with no excessive heat build-up on the ears.

Soundcore Space Q45 – up to over 70 hours of battery life

A good 33 hours of listening time can be achieved with the Soundcore Space Q45 when the noise cancellation is used continuously at the maximum setting at a high playback volume, but more than 70 hours of runtime can be achieved in standard mode. If the battery is empty, it can be fully recharged in 100 minutes via the USB-C port. A quick charge of five minutes also provides capacity for two and a half hours in ANC mode or three hours and 40 minutes in basic mode. These headphones have a 3.5mm input on the right side of the earcup with Hi-Res Audio certification, which also allows for wired use. A corresponding mini-jack cable with a length of 100 centimetres as well as a USB-C to USB-A charging cable is included in the package.

How easy it is to use the Space Q45

Switching on the headphones, which support multipoint connections with two devices simultaneously, is done by briefly pressing and holding the power button on the left side while holding it longer puts the system directly into pairing mode. The NC button for switching between ANC, transparency and basic modes can also be found on the left side, and it is possible to specify which modes are to be switched between via the app. You can also choose whether pressing twice switches the Soundcore Space Q4's BassUp function on and off. The other controls are located on the right-hand side of the headphones. Playback can be controlled via the Play/Stop button, which is also used to answer and end phone calls and, when pressed twice, activates the voice assistant. A short press rejects calls and enables muting of the microphones. The plus and minus buttons can also be used to control the volume and to select a track by pressing and holding the plus button to skip forward and the minus button to skip back. Unlike the NC button, commands for device control cannot be configured via the app; this would be a desirable enhancement. Nevertheless, the remote functions perfectly. The wireless connection also proved to be very stable during our test, bridging several rooms and one floor inside buildings without any problems. Outdoors, a distance of 30 metres could be achieved.
