- a) This document may contain confidential information that is the property of the NHLS and the Client.
- b) No part of the contents may be used, copied, disclosed or conveyed in whole or in part to any party in any manner whatsoever other than for preparing a proposal in response to this RFQ, without prior written permission from NHLS and the Client.
- c) All Copyright and Intellectual Property herein vests with NHLS and its Client.
- d) Late and incomplete submissions will not be accepted.
- e) SDB 7 (form of offer) must be completed, and should the total RFQ prices differ, the one indicated on the form of offer shall be considered the correct price.
- f) Any bidder who has reasons to believe that the RFQ specification is based on a specific brand must inform NHLS before RFQ closing date
- g) Bidders are required to submit a valid Tax Clearance Certificate and Tax clearance verification PIN, Failure to submit the Tax Pin and valid Tax Clearance Certificate will result in the invalidation of this RFQ.
- h) It is the responsibility of the bidder to ensure that NHLS is in possession of the bidder's valid Tax Clearance certificate. The onus is on the bidder to ensure that NHLS receives a valid Tax Certificate as soon as the validity of the said certificate expires.
- i) **A compulsory clarification or site meeting NONE**
- j) The tenderer shall inspect and examine the Site and its surroundings and shall satisfy himself/herself before submitting his/her quotation. The Supplier shall allow in the quotation for all deliverables as stipulated in the scope, labour, material, consumables, accessories, software, supervision, overhead costs, profit, royalties, all taxes, levies, duties, variations in exchange rates (if applicable), disbursements and everything necessary for the execution and completion of the works in accordance with the quotation documents.
- ii. Value Added Tax (VAT) shall be excluded from the rates and prices and provided for as the total VAT on the cost of the Works in the Summary of Schedule of Rates and Prices.
- iii. The Supplier rates and prices shall be fixed for the duration of the contract and not subject to adjustment except as provided for in the conditions of contract.

- v. The NHLS reserve the right to do due diligence on the quotations and to benchmark prices quoted.

Delays in the supplier's performance

- . Delivery of the goods and performance of services shall be made by the supplier in accordance with the time schedule prescribed by the purchaser in the contract.
- . If at any time during performance of the contract, the supplier or its subcontractor(s) should encounter conditions impeding timely delivery of the goods and performance of services, the supplier shall promptly notify the purchaser in writing of the fact of the delay, its likely duration, and its cause(s). As soon as practicable after receipt of the supplier's notice, the purchaser shall evaluate the situation and may at his discretion extend the supplier's time for performance, with or without the imposition of penalties, which case the extension shall be ratified by the parties by amendment of contract.
- . The right is reserved PROVISION outside of the contract small quantities or to have minor essential services executed if an emergency arises, the supplier's point of supply is not situated at or near the place where the supplies are required, or the supplier's services are not readily available.
- . Except as provided under GCC Clause 25, a delay by the supplier in the performance of its delivery obligations shall render the supplier liable to the imposition of penalties, pursuant to GCC Clause 22, unless an extension of time is agreed upon pursuant to GCC Clause 22.2 without the application of penalties.

1. Introduction

South African Vaccine Producers is currently using the Sesame Database Manager software from Lantica Software LLC, which forms part of the SAVP Quality Management System.

Sesame is a client-server database application, developed to manage SAVP quality control sample booking and tracking. The database is used to Quarantine tested samples, Release tested samples, Reject non-conforming samples, print reports, track the status of samples received and ensure all tests have been completed.

The database has historical data on SAVP testing materials. The type of samples to be booked into the Sesame database include Raw and Packed Materials, Lignocaine, Bulk product, Final filled product, Stability, Water testing System, Contract Testing, and Biologicals.

The databases must be able to draw information from each other for reporting, releasing or rejecting products. Sample stickers must be printed by the system with accurate information.

Data integrity is important, sample information that has been booked in or loaded onto the database, must not be deleted or changed.

2. Objectives

This document serves to specify all the user requirements specifications for the Support and Maintenance of the SAVP Sesame Database Manager for a period of 12 Months.

3. Scope

The URS applies to the Support and Maintenance of SAVP Sesame Database Manager for a period of 12 Months. Maintenance and support of the Servers, server operating system, network, and client PCs will be performed by the NHLS.

4. Description

The Vendor will provide the following services:

- 1. Database Administration
 - a. Configuration of the Sesame Database as required for business operations.
 - b. Monitoring and troubleshooting the Sesame Database Manager to ensure optimal uptime and usability.
 - c. Performance tuning to ensure the optimal working of the Sesame Database.
- 2. Backups and Recovery
 - a. Working with the NHLS Server teams to ensure that effective backup procedures are in place for the backups of the Sesame Database.

- b. Monitoring the status of the backups and doing recovery testing.
- 3. Client Workstations
 - a. Providing support for the Sesame Database Manager client software on the SAVP workstations, including installation, troubleshooting and configuration of the software and related functionality required in the operating system.
- 4. User Support
 - a. Proving user support on the operation of the Sesame Database Manager
 - b. Providing documentation and training to nominated SAVP super users for the management of users.
- 5. Service Management
 - a. Providing procedures for SAVP staff to log tickets for support and other requests
 - b. Provide monthly reports of support provided including the status of tickets.
