Delays in the supplier's performance

As soon as practicable after receipt of the supplier's notice, the purchaser shall evaluate the situation and may at his discretion extend the supplier's time for performance, with or without the imposition of penalties, in which case the extension shall be ratified by the parties by amendment of contract.
- iii. The right is reserved to procure outside of the contract small quantities or to have minor essential services executed if an emergency arises, the supplier's point of supply is not situated at or near the place where the supplies are required, or the supplier's services are not readily available.
- iV. 1. PURPOSE

To urgently request assistance from Supply Chain Management to purchase, an accurate and calibrated weighing balance for the purpose of weighing Mice, Rats and Guinea Pigs in the SPF Unit.

2. BACKGROUND

Currently, SPF unit is operating with only one weighing scale shared among multiple tests and animal rooms. This has created operational delays and increased the risk of inaccurate dosing due to equipment overuse and limited calibration scheduling. The availability of a second balance will help ensure continuous and efficient weighing operations, improve animal welfare, and maintain data accuracy during experimental procedures.

3. DISCUSSION

Accurate weighing of animals before injection is critical to ensure dosing precision and compliance with experimental and ethical standards. Having only one operational balance in the SPF unit causes workflow delays, particularly when multiple tests (e.g., innocuity, potency, and safety testing) are scheduled concurrently. Annual certification and calibration are mandatory to maintain compliance with quality assurance and GLP (Good Laboratory Practice) requirements. Procuring an additional balance and ensuring calibration will improve reliability and consistency in testing outcomes.

4. ORGANIZATIONAL AND PERSONNEL IMPLICATIONS

Providing new balance with a printer will enhances efficiency and reduces waiting time for weighing animals, improves compliance with GLP and SANS 10386:2021 and reduces workload pressure and enhances accuracy of staff performing animal weighing.
