- a) This document may contain confidential information that is the property of the NHLS and the Client.
- b) No part of the contents may be used, copied, disclosed or conveyed in whole or in part to any party in any manner whatsoever other than for preparing a proposal in response to this RFQ, without prior written permission from NHLS and the Client.
- c) All Copyright and Intellectual Property herein vests with NHLS and its Client.
- d) Late and incomplete submissions will not be accepted.
- e) SBD 7 (Form of offer) must be completed, and should the total RFQ prices differ, the one indicated on the price declaration shall be considered the correct price.
- f) Bidders are required to submit a valid Tax Clearance Certificate and Tax clearance verification PIN, Failure to submit the Tax Pin and valid Tax Clearance Certificate will result in the invalidation of this RFQ.
- g) It is the responsibility of the bidder to ensure that NHLS is in possession of the bidder's valid Tax Clearance certificate. The onus is on the bidder to ensure that NHLS receives a valid Tax Certificate as soon as the validity of the said certificate expires.

- m) The NHLS reserves the right to benchmark prices quoted.
- n) The General Conditions of Contract (GCC) issued by National Treasury are applicable.
- o) I Quotation All-Inclusive
 - i. The Supplier shall allow in the quotation for all deliverables as stipulated in the scope, labour, material, consumables, accessories, software, supervision, overhead costs, profit, royalties, all taxes, levies, duties, variations in exchange rates (if applicable), disbursements and everything necessary for the execution and completion of the works in accordance with the quotation documents.
 - ii. Value Added Tax (VAT) shall be excluded from the rates and prices and provided for as the total VAT on the cost of the Works in the Summary of Schedule of Rates and Prices.
 - iii. The Supplier rates and prices shall be fixed for the duration of the contract and not subject to adjustment except as provided for in the conditions of contract.
 - iv. The offer must be in ZAR currency.
 - v. The NHLS reserve the right to do due diligence on the quotations.

1. ***Delays in the supplier's performance***

Delivery of the goods and performance of services shall be made by the supplier in accordance with the time schedule prescribed by the purchaser in the contract.

- i. If at any time during performance of the contract, the supplier or its subcontractor(s) should encounter conditions impeding timely delivery of the goods and performance of services, the supplier shall promptly notify the purchaser in writing of the fact of the delay, its likely duration, and its cause(s). As soon as practicable after receipt of the supplier's notice, the purchaser shall evaluate the situation and may at his discretion extend the supplier's time for performance, with or without the imposition of penalties, in which case the extension shall be ratified by the parties by amendment of contract.
- ii. The right is reserved to procure outside of the contract small quantities or to have minor essential services executed if an emergency arises, the supplier's point of supply is not situated at or near the place where the supplies are required, or the supplier's services are not readily available.
- iii. Except as provided under GCC Clause 25, a delay by the supplier in the performance of its delivery obligations shall render the supplier liable to the imposition of penalties, pursuant to GCC Clause 22, unless an extension of time is agreed upon pursuant to GCC Clause 22.2 without the application of penalties.
- iv. Upon any delay beyond the delivery period in the case of a supplies contract, the purchaser shall, without cancelling the contract, be entitled to purchase supplies of a similar Functionality and up to the same quantity in substitution of the goods not supplied in conformity with the contract and to return any goods delivered later at the supplier's expense and risk, or to cancel the contract and buy such goods as may be required to complete the contract and without prejudice to his other rights, be entitled to claim damages from the supplier.

2. ***Penalties***

- i. EGORNOMICS OFFICE CHAIR

PURPOSE

This document outlines the mandatory technical, ergonomic, and safety requirements for a new office chair designed to support users weighing up to 150kg comfortably and safely during prolonged use. The chair must promote proper posture, adjustability, and long-term durability.

SCOPE

This specification applies to all office chairs being procured for general or task-oriented office work where user weight does not exceed 150kg.

MANDATORY REQUIREMENTS

3.1 Weight Capacity and Structural Integrity

3.1.1 Weight Rating: The chair must be explicitly rated and certified by the manufacturer to support a minimum dynamic weight of 150kg. Proof of this rating must be provided.

3.1.2 Frame: The primary frame must be constructed from reinforced nylon or die-cast aluminum/alloy to ensure rigidity and prevent flexing or failure.

3.1.3 Base: Must be a 5-point or 6-point base constructed from reinforced nylon or metal (aluminum/steel). A 5-point base is mandatory for stability and safety.

3.1.4 Casters: Must be suitable for hard floor (e.g., polyurethane) or carpeted use (specify if a preference exists). Casters must roll smoothly and quietly under the specified load.

3.2 Ergonomic Adjustability

The chair must feature independent, intuitive, and tool-free adjustments for the following functions:

3.2.1 Seat Height Adjustment: Pneumatic (gas lift) height adjustment. Range must accommodate a seated height from 42cm to 55cm (16.5" to 21.5") from the floor.

3.2.2 Seat Depth Adjustment: The seat pan must slide forward and backward to accommodate different leg lengths. A minimum adjustment range of 10cm (4 inches) is required.

3.2.3 Backrest Height and Lumbar Support Adjustment: The backrest and/or integrated lumbar support must be vertically adjustable to fit the natural curve of the user's spine. A locking recline mechanism is mandatory, allowing the user to set a preferred tilt tension.

3.2.4 Armrests: Must be fully adjustable (4D or 3D). As a minimum, armrests must adjust for:

Width (pivoting in/out or sliding side-to-side)

Depth (forward/backward)

Pivot (optional but preferred)

Armrests should be padded and of a sufficient width.

3.2.5. Headrest/ head support

3.3 Seat Design and Comfort

3.3.1 Seat Dimensions: The seat pan must be sufficiently large and supportive.

Width: Minimum 50cm (20 inches).

Depth: (After adjustment) Must provide adequate support without pressing behind the knees.

3.3.2 Seat Padding: High-density, cold-cure molded foam with a minimum density of 35kg/m³. Padding must be resilient to long-term compression and not bottom out under the specified weight.

3.3.3 Waterfall Front: The seat edge must have a downward, waterfall-style curve to reduce pressure on the underside of the thighs and improve circulation.

3.4 Backrest Design

3.4.1 Dimensions: The backrest must be tall and wide enough to provide full shoulder support, typically at least 45cm (18 inches) wide.

3.4.2 Lumbar Support: Must provide pronounced, adjustable support that contours to the lumbar (lower back) region. A built-in, adjustable lumbar mechanism is preferred over a separate cushion.

3.4.3 Synchro-Tilt Mechanism (Preferred): A synchro-tilt mechanism, where the seat and backrest tilt in a synchronized ratio, is highly desirable for maintaining ergonomic alignment while reclining.

3.5 Materials and Upholstery

3.5.1 Fabric: High-quality, breathable mesh or commercial-grade fabric. Fabric must be abrasion-resistant and meet or exceed 100,000 double-rubs (Martindale test) for durability.

3.5.2 Alternative: High-quality PVC or polyurethane leather is acceptable, provided it is perforated for breathability.

3.6 Safety and Compliance

3.6.1 Gas Cylinder: The pneumatic cylinder must be certified to an international safety standard (e.g., ANSI/BIFMA, SGS, TUV, or ISO).

3.6.2 Warranty: A minimum warranty of 5 years on the mechanism, frame, and casters, with a minimum of 2 years on upholstery and foam. The warranty must explicitly cover use up to 150kg.

5.THE EVALUATION PROCESS

Stage 3: Price and Specific Goals

The final evaluation phase will be based on **Price and Specific Goals**.

- a) Determination of Percentage for Price – 80 points,
- b) Determination of level for for Specific Goals – 20 points.

5 PREFERENCE POINTS CLAIM FORM IN TERMS OF THE PREFERENTIAL PROCUREMENT REGULATIONS 2022

This preference form must form part of all bidders invited. It contains general information and serves as a claim form for preference points for specific goals.

(g) **“Youth”** Has the meaning assigned to it in section 1 of the National Youth Development Agency Act, 2008 (Act No. 54 of 2008)

“Specific goals” means specific goals as contemplated in section 2(1)(d) of the PPPFA which may include contracting with persons, or group of persons, historically disadvantaged by unfair discrimination on the basis of race, gender and disability including the implementation of programmes of the Reconstruction and Development Programme as published in Government Gazette No. 16085 dated 23 November 1994.
